Subject: Grant of **Renewal of Provisional Affiliation** for B.A. (Hons) in English, Khasi, Political Science, Education, Economics, History; B.A. Electives in Khasi, English and EVS programme - regarding.

Madam/Sir,

With reference to the subject indicated above, we are pleased to inform you that the 33rd Emergent Academic Council Meeting of the University held on December 4, 2024, after considering the recommendation of the 85th Affiliation Committee, has resolved, **Vide A.C. Resolution No:EAC:33:2024:5:7(i);Section:A:Item:9** to grant your college renewal of Provisional Affiliation for B.A. (Hons) in English, Khasi, Political Science, Education, Economics, History; B.A. Electives in Khasi, English and EVS Programme for a period of 3 (three) years with effect from January 2024-25 to 2026-27 Academic Session.

Kindly note that as mandated by the Inspection Team, the College is required to **fulfill the following conditions:**

1. The College must immediately initiate the process for recruitment of 1 (one) more Assistant Professor in the Department of Khasi to meet the required number of five. The appointment must be done through a proper Selection Committee constituted by the University and in strict compliance with the UGC guidelines in such matters.
2. The College must encourage those teachers without Ph.D. or NET qualification to clear the UGC-NET Examinations and to enroll themselves for a Ph.D. Programme.
3. The College must procure more number of titles and copies of books to meet the norms prescribed by the NEHU Ordinance and to prescribe at least two journals per department. The College should enroll as a member of N-LIST programme to gain access to e-books and e-journals.

The Academic Council also recommended that in view of the need for being NEP 2020 compliant, the college management must make all efforts to upgrade the College into a multi-faculty institution to facilitate introduction of multi disciplinary courses at its campus as has been envisaged in the New Education Policy (NEP-2020).

The office of the undersigned may duly be informed of the compliance status of the conditions mentioned above within three months from the date of receipt of this letter. The college is also required to apply for renewal of its Provisional Affiliation six months prior to the expiry of the Affiliation. As such, the application for renewal of Provisional Affiliation of the college may please be submitted to this office by **June/July 2027**.
